## Department of Mathematics and Computer Science

#### **Request Name Change**

- Since its inception in AY 2019-20 the engineering program has been housed in the Department of Mathematics and Computer Science.
- Despite COVID impacts, enrollment in the engineering program has been growing.
- For recruiting, marketing and accreditation, it is necessary that the engineering program is acknowledged in the name of the department.
- On October 7, 2022 a unanimous motion was adopted by the Department to change its name to the Department of Mathematics, Engineering, and Computer Science.
- Dr. Naveed Zaman, Dean of NSM is in complete agreement with the unanimous motion adopted by the Department to change its name to the Department of Mathematics, Engineering, and Computer Science and requests a motion from the BOG.



### **Description**

- The Doctorate of Education in Leadership Studies will serve institutions and communities by expanding the knowledge base and practices of leaders leading to increased achievement of institutions while addressing social justice, fairness, and equity and building safe, caring, and healthy environments.
- Practitioner based model: candidates engage in an action-based research plan with single site from first semester to the culminating capstone research thesis.
- Fully online, 2-year program
  - Program total = 48 hours
    - 12 courses = 36 hours of content
    - 4 courses = 12 hours of research



#### **Program Need**

- WVU has a certificate in Leadership but no graduate degree.
- MU's Ed.D. in Leadership Studies is a generalist leadership focus with a traditional research model.
- WVSU's Ed.D. program will focus on Professional Practice and will be the first practitioner-based action research model in the State of West Virginia.
- WV faces a critical shortage in all areas of education including administration and leadership, which will be addressed by the program.

## **Program Need**

- Marshall and WVU have EdD programs in Research/Scholarship. WVSU's EdD program would be in Professional Practice.

#### MEETING MINUTES

## West Virginia State University Board of Governors Advancement Committee Erickson Alumni Center Thursday, October 27, 2022

#### I. Call to Order and Roll Call

Chair Pitchford called the meeting to order at 9:52 am

#### II. Administrative Clerk (Susan Compton) called the roll.

Members in attendance were Mr. Mark Davis, Mr. Ian Flores, Dr. Chris Jackson, Mr. Charles E. Jones, Mr. Mark Kelley, Ms. Tracey McKibben, Mr. James Payne, Dr. Jeffrey Pietruszysnki, Ms. E. Gail Pitchford, Mr. Lester Raines, and President Cage

Members not in attendance were Mr. Kenneth Gray and Mr. Caleb Shepherd.

Guests in attendance were Ms. Patricia Schumann, Mr. Trey Jones, and Mrs. Belinda Fuller.

#### III. Verification of Appropriate Notice of Public Meeting

Ms. Pitchford verified the Appropriate Notice of Public Meeting.

#### IV. Approval of September 8, 2022 Minutes

Ms. Pitchford entertained a motion to approve minutes from the September 8, 2022 meeting. Mr. Kelley made a motion to approve; the motion was seconded by Mr. Payne. Motion carried.

#### V. Financial Reports

Ms. Schumann presented the financial reports as of September 30, 2022. At the end of the first quarter we were at \$2.4 million total giving. Current participation is trailing from last year just slightly in terms of number of donors and number of gifts.

Ms. Schumann also shared significant commitments this quarter. The largest is an in-kind contribution from Student Freedom Initiative valued at \$1.9 million. We have also received a new gift from the Jacobson Foundation this year. We have received gifts from Marathon Petroleum, an unrestricted gift and 5 additional gifts at \$10,000 each. Mrs. Pitchford asked if the Student Freedom Initiative is a pledge over a period of years and how it is structured. Ms. Schumann shared this is an in-kind gift for cyber security infrastructure upgrades and deferred to Mr. Jones. Mr. Jones shared the implementation with our I.T. will be next year.

Ms. Schumann reported the cash flow for the first quarter aligns with the gift report. We have not received payments on pledges for this fiscal year; however, we have received \$319,000 of payments on pledges prior to FY2023. Ms. Schumann shared that two of these are payoffs of significant pledges made during the capital campaign. She also pointed out that non-charitable revenue includes homecoming event registrations and athletics rentals. The total cash for the first quarter was \$898,027.

Ms. Schumann presented the WVSU Foundation Endowment report. The gift principal value stands at \$7.7 million and includes the payoff from the loan to the University which has come back into the managed portfolio. The total in the managed portfolio is \$11.2 million. In addition, there is still one loan out to the athletics department which is recorded as a fixed income asset. The balance on this loan is \$337,500. Ms. McKibben commented that we are under-performing benchmarks and expressed her concern. She advised we need to push back on our advisors. Ms. Schumann shared there was a discussion in the Foundation's Finance & Audit Committee last week about evaluating our vendor relationships and in the coming year the Foundation plans to do that. Ms. Pitchford asked if they would do an RFP. Ms. Schumann responded that there would be an RFP.

The net for contributions/withdrawals this period was \$861,857 with the majority of that being the loan payoff coming back into the portfolio. There were also scholarship awards going out.

The portfolio performance for the quarter was a -4.5%. The YTD was -16.35%. The 10-year average is at 5.39%. Ms. McKibben asked for clarification on matching Title III funds, specifically if alumni make contributions if Title III matches it. Ms. Schumann advised yes, but the minimum contribution to establish an endowment is \$25,000. Title III funds can be used to match existing or new funds. Ms. McKibben asked if we lead with this information when speaking with donors. Ms. Schumann shared that it depends on the donor's goals. If the donor wants to have an immediate impact and wants their fund to start paying out, then they may not want to put 100% of their contribution into Title III because of the very restricted spending policy. However, if their priority is long term growth then it is a great tool. Another option with a larger endowment is to retain some in the primary endowment account, and transfer a portion to the Title III account, thereby retaining a stable revenue stream while also capturing matching funds for a portion of the gift.

#### VI. Fall 2022 Alumni Relations and Annual Giving Report

Ms. Fuller presented reports on alumni relations and annual giving. She shared this year there was a full homecoming schedule and it was exciting to see so many back on campus. This year WVSU honored two former presidents, Dr. Thomas W. Cole, Jr. and Dr. Hazo W. Carter, Jr during homecoming.

Ms. Fuller also shared that during this year's homecoming football game, there were two check presentations. The family of Glover L. Smiley, Jr. presented a check for \$100,000 and the Alpha Kappa Alpha Sorority, Inc. presented a check for \$126,000 in honor of their centennial celebration.

Ms. Fuller also reported on the upcoming giving appeals. The early fall appeal will be mailed to all alumni and friends, approximately 21,000. Ms. Fuller also shared that there has been a delay in mailing due to a nationwide paper supply chain issue. For Giving Tuesday on November 29, 2022, WVSU will be participating in a social media movement.

Ms. Fuller announced the establishment of a specialized WVSU license plate. This plate requires a commitment of 250 prepaid plates before it can be issued. The deadline is April 21, 2023 for prepaid sales. More information can be found online on the Connect website. The initial registration fee is \$99, then will be \$66 per year to retain the specialized plate design. You do have to be a resident of WV to receive this plate. Ms. McKibben shared she felt this was great for branding.

#### VII. Corporate Partnerships Report

Mr. Jones reported that recent partnership activity includes The Tom Joyner Foundation, The J.M. Smucker Company, Toyota, and Nucor. He shared WVSU is one of the first HBCU's to participate in The Tom Joyner Foundation tour; this foundation provided a \$5,500 scholarship for a senior undergraduate with financial need. Mr. Jones shared J.M. Smucker reached out to WVSU in their effort to build a workforce development pipeline. This particular partnership will include Career Services and WVSU National Alumni Association. Mr. Jones reported on the recent check presentation by Toyota to fund a program in area middle schools to encourage students to consider STEM field. Mr. Jones also reported on the relationship with Nucor. Our current job is to help them fill 800 jobs over the next several years. We have also received a signed agreement and Nucor will be sponsoring the men's basketball game against University of Charleston. Worley just held a Worley Day on campus with an info session table and classroom presentations. Upcoming engagement events include Nucor Day on November 10, 2022 and Sherwin Williams Day with a date that is still to be determined.

Mr. Jones also reported that we currently have 7 potential corporate gifts in the pipeline, 4 with a 6-figure value. In addition, Mr. Jones shared our fundraising priority is Lakin-Ray Field. There is a \$250,00 matching challenge from the Jacobson Foundation. Currently we have raised approximately \$37,000. There is a temporary plaque at the entrance of the field which will be finalized at the end of fall sports season. Donors may have their name placed on the permanent plaque with a minimum gift of \$1,000. Dr. Jackson questioned if payroll deduction would be an

option for faculty/staff. Mr. Jones shared that payroll deduction can be made for faculty/staff and the Foundation is currently working on a message about this opportunity.

With there being no further business, Chair Pitchford adjourned the meeting at 10:32 a.m.



#### **MEETING MINUTES**

West Virginia State University Board of Governors Business Affairs Committee Erickson Alumni Center, Grand Hall Thursday, October 27, 2022 9:00 a.m.

#### I. Call to Order and Roll Call

Mr. James Payne called the meeting to order at 10:41 a.m.

#### **II.** Members Present:

The clerk called the roll. Members present were Mr. Payne, Ms. McKibben, Mr. Kelley, Mr. Raines, Mr. Jones, Mrs. Pitchford, Mr. Davis, Dr. Jackson, and Dr. Pietruszynski. There was a quorum for this meeting.

#### III. Verification of Appropriate Notice of Public Meeting

Mr. Payne verified the Appropriate Notice of a Public Meeting.

#### IV. Review and Approval of September 23, 2021 Meeting Minutes

Mr. Payne asked for a motion to approve the meeting minutes for September 8, 2022. Ms. McKibben made a motion, and it was seconded by Dr. Jackson. Motion passed.

#### V. FY22 Financial Audit Review

VP McAllister communicated that the audit was due on October 15, however, the audit review had wrapped up on Monday, October 24 of which the final report was issued on Tuesday, October 25. The CliftonLawsonAllen auditing firm will be on-site for the December Board of Governors session to go over the audit. In discussing the FY22 financial audit, CLA noted an internal control finding identified as a material weakness with internal controls over financial monitoring. Outlined in the Governance Letter, there are five items which include corrected missed statements, an adjustment to reduce cash and cash equivalence in accounts payables as of June 30, 2021 in the amount of approximately \$343,000 due to double booking of deposits dating back to 2019, an adjustment to increase capital assets in accounts payables of approximately \$443,930 due to construction that took place in 2021 that was not recorded as of June 30, 2021, an adjustment to reduce advances from federal government and miscellaneous revenues in the amount of approximately \$270,973 to reflect the correct liability to the federal government relating to Perkins of which this number had not been adjusted since 2002. VP McAllister explained the process of the Perkins Loan Program and how the University handles the funds issued by Perkins. VP McAllister is actively working on liquidating the Perkins as it was elected by the university to do so several years ago, however, it has not been completed as of yet. This debt is being turned over to the Federal Department of Education so that the liability is no longer on the University's books and the FDOE will collect the debt. Areas of concern were identified in the process of searching for unrelated information. No additional monies are owed to the federal government outside of the normal Perkins liability funds. The scope of the audit review fluctuates each year which may explain why certain issues were not identified sooner. Other adjustments identified were to remove an allowance related to Perkins in the amount of \$196,000 which is related to the liability previously identified as doubtful debt of which the university should not carry the debt since it is a government supported loan therefore the auditors asked that it is removed as the loans date back to 1988. As the liability has been carried on the University's books, it is considered a pass-through and the liability should have been decreasing as the university pays the funds back to the federal government. The largest concern of the findings was related to the \$2.7 million of the student portion of the HEERF funding which had not been booked due to being

processed through an outside bank account that does not reflect on the ledger; going forward, the funds will be run through a different account. In curving the immature processes associated with the university finances due to a lack of proper controls and high staff turnover, automated processes will be set in place to align the controls and procedures accordingly. Regular reconciliation of the trial balance accounts will be implemented to ensure proper controls are being applied. The consolidated financials as presented in the audit pulls the University and Research & Development together. The balance sheet reflects a small increase in assets, a decrease in liabilities, and the income statement shows a \$4.8 million net position which is a \$2.4 million increase from 2021 on an accrual basis resulting in a positive cash position. Overall the university received a clean audit opinion outside of the one finding.

#### VI. FY23 Financial Update

a. FY23 Quarter Financial Statement

As of September 30, 2022, the university had \$9.8 million in revenue, \$11.3 in operating expenditures with a total operating margin of -\$1.5 million. There was \$211,000 in HEERF expenditures for the quarter, ending in the red with \$1.7 million. At the end of September, \$1.8 million of Promise and High Education funds that had yet to be received due to a delay in financial aid disbursement which would have balanced the budget. A HEERF drawdown has not been made for this fiscal year, therefore there are funds to compensate for the \$211,000 expenditure. There is \$10 million in HEERF funding remaining, however, it is important to try and reserve as much of that as possible as some of the funds are earmarked to renovate Sullivan Hall this upcoming year.

b. September Revenue & Expense

The university received the quarterly \$3.2 million of state appropriations in July and the second portion was received on October 1, 2022. The salaries and wages makes up the largest portion of expenditures while tuition and fees is the largest portion of revenue with state appropriations following that number. During the first quarter of the year, the FY22 actuals were higher than the FY23 actuals, partially due to not receiving the \$1.8 in Higher Education and Promise revenue. Scholarships and waivers are slightly up from FY22.

c. Liquidity Monitoring

There are only \$150,765 in outstanding payables with the majority being under 60 days old of which one invoice of \$72,000 makes up a large portion of the outstanding debt. In July there were 43 days of cash-on-hand. In August, the number of days dropped to 27 days and there is currently 31 days of cash-on-hand of \$76,629. The goal is to stay above 30 days of cash-on-hand.

d. Accounts Payable Schedule

The aged payables reflect accounts that are over 90 days. Such payables have an overall debt owed of \$7,650.72 mostly due to more documentation needed to initiate the payment.

#### VII. Adjournment

With there being no other business, Mr. Payne moved to adjourn the meeting at 11:32 a.m.



# Fiscal Year 2023 Liquidity Monitoring










# Accounts Payable Schedule

#### IV. Enrollment Management

#### a. Year to year application comparisons

Dr. Sowell stated that freshman application numbers for spring semester enrollment are up 3.75 %. However, we are down 15% admitted freshman due to the 48% of incomplete applications. We are also under 76% for confirmed but as the incomplete numbers go down the admitted and confirmed numbers will increase. We are behind in transfer students in all categories and are addressing with admissions department. Fall 2023 applications are 23% ahead of the previous year with 97% more incomplete applications. Incomplete applications are due to lack of official transcripts. We are 54% higher for confirmed freshman for fall 2023.

#### b. Enrollment Strategies and Partnerships

Slate is our new CRM and is currently live and integrated. This allows us easier access for communication with applicants. It allows applicants to chart their own progression.

The Common application is a tool where students can apply to more than one college at a time and will go live next week. Previously, we were the only West Virginia college not participating in this application. Everything in Slate integrates with the Common App and Banner. This should help with recruiting international students without expensive travel. We signed an MOU with New Seasons Youth out of Nassau.

Bahamas because they participate in national government funded scholarships. We guarantee two scholarships for qualified students and gain exposure to other scholars.

The Stop Out Campaign was recently started for students who have WVSU credits but have not returned in the past five years. This aims to re-enroll these 1500 students and our goal is 20%.

Early Enrollment program will receive additional correspondence to encourage their four-year degree. We are also working with Enroads, a national internship program for college readiness for students of color.

#### c. Enrollment Goal

The goal for enrollment for Fall 2023 is 2100 students, new freshmen and transfers combined at 500 and new on campus students at 158. This number does not include dual enrollment students.

#### V. Student Affairs

a. Office of Student Advocacy Update
Jaleesa Nunez, director of Student Advocacy discussed the new MyWVSU app. Its
purpose is to make information more accessible to everyone pertaining to events,
academics and financial aid. She also discussed her role in student interactions to
help students be more successfully and it aids in retention.





#### RESOLUTIONS

#### THE WEST VIRGINIA STATE UNIVERSITY BOARD OF GOVERNORS

WHEREAS, West Virginia State University is the title owner and caretaker of the Cabell Family Cemetery interring the remains of Samuel and Mary Barnes Cabell and 24 of their descendants and family members as well as those of J. M. McHenry Jones, the third president of the predecessor of West Virginia State University.

WHEREAS, the Cabell Family Cemetery is irrevocably and entirely dedicated to the interment and peaceful repose of the remains of those persons now interred there.

WHEREAS, Langley Spurlock, of Washington, D.C., and Watson Jennison, of Toronto, Ont., both graduates of the predecessor of West Virginia State University, are the last known and surviving descendants of the Cabell Family through the line of a daughter of Samuel and Mary Barnes Cabell, Eunice Cabell Brown who was married to Zachariah Taylor Brown.

WHEREAS, the Brown Family Cemetery, now located on a one-acre parcel near West Virginia State University, inters the remains of Eunice Cabell Brown, Zachariah Taylor Brown and 16 of her descendants and family members under the current care and at the current cost of Mr. Spurlock.

WHEREAS, Mr. Spurlock and Mr. Jennison, advanced in age, now seek to make lasting and stable arrangements for the future care of the remains of the 18 persons now interred in the Brown Family Cemetery and, accordingly, ask West Virginia State University to consent and agree to the re-location and re-interment of the remains of those 18 persons in the Brown Family Cemetery so long as all of the costs therefor are incurred and borne by Mr. Spurlock or others.

WHEREAS, the Board of Governors of West Virginia State University conclude that the recited requests of Mr. Spurlock and Mr. Jennison are thoroughly in keeping with the purposes for which the Cabell Family Cemetery exists and for which West Virginia State University holds title to and cares for the Cabell Family Cemetery.

WHEREAS, upon the requests of Mr. Spurlock and Mr. Jennison, the Board of Governors of West Virginia State University conclude, upon investigation, that the Cabell Family Cemetery contains sufficient room to inter the remains of the 18 persons now interred in the Brown Family Cemetery.

WHEREAS, the Board of Governors of West Virginia State University desire to consent and agree to the requests of Mr. Spurlock and Mr. Jennison and to grant a license to them for the purposes so recited.

NOW, THEREFORE, in consideration of the foregoing:

BE IT RESOLVED that West Virginia State University, a public body, be and it hereby is authorized to grant to Langley Spurlock and Watson Jennison, or either of them, and to their

respective representatives, executors or administrators, without charge therefor, the license and right to re-locate and reinter the remains of the 18 persons now interred in the Brown Family Cemetery, at the sole cost and expense of Mr. Spurlock or Mr. Jennison, or their estates, including all of the costs of exhumation, excavation, opening, re-interment, vaults, markers, headstones and other goods and services necessary or reasonably necessary to consummate the same.

BE IT FURTHER RESOLVED, that the Chair and the Secretary of the Board of Governors of West Virginia State University and the President by his offices be and they hereby are authorized to negotiate, execute, sign and deliver any and all agreements, documents or other items and to take all other actions necessary or reasonably necessary to consummate the same.




