Award Procedure

*****DRAFT*****

1. Verbal offer of scholarship tendered to eligible student.
2. Verbal acceptance of scholarship offer by eligible student.
3. Office of Recruitment prepares written scholarship offer inclusive of terms and conditions. (Patterned after Athletics Letter of Intent – still to be drafted)
4. Scholarship offer signatures procured from Director of Recruitment or designee; Director of Student Financial Assistance or designee; and Dean of College of student's major field of study or designee.
5. Written scholarship offer sent to student via U.S. mail or similar form of conveyance.
6. Student has fourteen (14) days to sign and return agreement or the offer is null and void. Expiration of offer does not preclude reissuance.
7. Parent or Legal Guardian signature also required if student is less than eighteen (18) years of age.
8. Signed agreement returned to the Office of Recruitment.
9. Office of Recruitment notifies respective College of scholarship acceptance.
10. Student entered on to scholarship roster.

Conditions of Financial Aid

I understand that to qualify for this financial aid, I must:

- Fulfill the admission requirements of West Virginia State University and enroll as a full-time student at West Virginia State University.
- Comply with all Department of Intercollegiate Athletics responsibilities and established policies as determined by both the head coach of the sport(s) in which I participate as well as the Director of Athletics. Department policies are outlined in the West Virginia State University Student-Athlete Handbook.
- Meet and maintain eligibility requirements for athletic participation and financial aid established by the NCAA, WVIAC and West Virginia State University.

NCAA regulations restrict the total amount of financial aid a student-athlete can receive. WVSU Athletic Aid may be issued to pay tuition, on campus room, on campus board, required books, required supplies, and required student fees. WVSU Institutional Policy reduces Athletic Aid every time a student receives a grant, institutional scholarship or external scholarship. The student has the right to appeal by a committee outside of athletics within 14 days of removal per NCAA Rule anytime athletic aid is removed from their account per this document. I will notify Student Financial Aid, my Head Coach and the Director of Athletics if I receive a federal or state grant, work study or some other institutional scholarship or external scholarship. My Athletic Aid along with other grants maybe reduced to meet WVSU, NCAA and Federal regulations

I am aware that the amount of this aid may be immediately reduced or canceled during the term of this award if:

- I become ineligible for intercollegiate competition (e.g., by failing to carry 12 credit hours or by failing to meet progress towards degree requirements, NCAA violation, Institutional Good Standing, Institutional Code of Conduct violation, etc.);
- I leave school prior to the end of the award period;
- I give false information on my application, NLI, financial aid agreement, medical history, to the NCAA or the NCAA Eligibility Center;
- I fraudulently misrepresent my commitment under the conditions of this athletic grant-in-aid;
- I voluntarily withdraw from the sport for personal reasons; or
- I am not residing in the Institute, WV area while enrolled in classes.
- I am arrested, indicted, or break, Institutional, County, State, or Federal Law or Regulations


Please return (1) one signed copy of the WVSU Athletic Aid Award and (1) one signed NLI agreement. The documents must be returned by February 26, 2011.
